

From Mike Morris -Lay Chair

Andy's report gives a good flavour of what can be achieved when we work together and support each other in mission. My own thoughts continue the theme of our working to support and encourage each other, but also address some issues that we have to face in the coming months.

The future of the Community Centre in New Bradwell has been a source of concern to our friends in New Bradwell for some time. But we feel that this is an issue for the wider Partnership and with that in mind a small group has been set up to work with the Management Group of the Community Centre so that a new lease can be arranged. We have had an initial and very fruitful meeting and I am sure that more will follow as we try to work out how to overcome what appeared at first to be an insurmountable problem. In turn, by our working with the Management Group, the church will be seen to be actively involved in, supporting and working with the community.

We also hold in our thoughts the concerns for the future of the Cross and Stable community. Whilst it is for that congregation to determine the way they wish to go, it is for all of us to be there and help them grow as God would want them to grow. Can I ask that the Cross and Stable particularly remain in our prayers and that we may all be ready to respond to any request that that church ask of us.

Sharing agreements and Constitutions remain to be finalised. It is important that the former is dealt with as soon as possible for without it monies from the sale of the Methodist Chapel in New Bradwell cannot be released to St James, where they can be used for improvements to the building. We shall be pressing for that conclusion.

Andy has touched on the retirement of Chris Collinge in May next year and the need to work now on how we will manage with one less Ministerial colleague. Our small Lay Group has had one meeting and another is arranged. But the group would welcome any ideas you might have, given that we are unlikely to be given another Anglican minister as a straight replacement for Chris. We would welcome any thoughts you may have on how we might best arrange ourselves, how best we might use the lay and ordained people we have and what the laity might take on so as to release time from a reduced ordained ministry team who we know are often overworked. And please

think, as they say, "outside the box". Remember "God works in mysterious ways...." Please encourage members of your congregations to consider given time and/or talents.

New ways of working within the Mission Partnership are still being determined now that the new constitution has been approved and we do not yet have a clear picture of how it will affect the LEPs. What had emerged from the review was that people felt that there should be a strong focus on mission. Structures are being developed to put this in place. The Mission Partnership will be an employer set up as a limited company to protect the Trustees and Executive. The Assembly at June will be asked to approve a new constitution, a standard one produced by the Charity Commissioners with the Mission Partnership aims and purposes included. New working patterns as approved by the last Assembly have been established and the new committees are running in tandem with the established ones. These new structures will have to be adopted by the June Assembly meeting along with an interim trustee's board (I am one of the interim trustees). The June Assembly will be the last Assembly in its present form whereby it makes business decisions. The matter of support for the LEPs is high on the agenda but has yet to be resolved.

The search of a new Ecumenical Moderator (to be titled in future the Director for Ecumenical Mission) is under way. It is proposed to advertise in denominational papers the week after Easter, short listing would be the first week in June with interviews 21st and 22nd June.

Finally on an upbeat note I have met over Easter a Methodist minister from Nigeria who is studying at the Ecumenical Institute at Bossey in Geneva. He has been visiting Milton Keynes to see how we operate ecumenically. What he has seen has inspired him. He has taken away pictures, both mental and digital, as well as ideas that he intends to share with his colleagues at the Institute and also ideas to take back to his homeland later in the year. Before coming here he had never even thought that the denominations could work together in ways that we now consider almost natural. So what we do both separately and together can inspire others and there is no doubt God will continue to inspire us in the coming months and years.

From the Rev. Andy Jowitt, Ministerial Team Leader

Much of the life of our Partnership and parish is within the life of each of the individual churches as they work out their mission and calling and serve God in their individual ways. Much of this life will be described in this collection of reports.

There is another important dimension and that is our 'togetherness': the ways we seek to support one another and encourage one another and work together.

Our evening services programme now provides an opportunity for worship each Sunday somewhere in the parish. This could be a quiet focus at the end of a busy day, or an opportunity to worship when a morning service wasn't possible, or a chance for us to pray for each other. The Partnership services hosted by the Cross & Stable Church have partly had this last aim in mind. It has been good recently to see people travelling to other parts of the parish over Holy Week.

Hosting and promoting the Passion Play performed by Riding Lights is one example of something that becomes possible when we work together. Sometimes one church takes a lead, and we are grateful to the lead taken by members of Christ Church in this instance.

The Week of Accompanied Prayer (enabling people to have a guided retreat experience without having to be away from home); the Room'n'ate programme of social events and speaker evenings for men; the Marriage Celebration dinner; the Marriage Preparation courses; the 'Glow in the Dark' party (providing an alternative to Hallowe'en); the Noah's Ark Party; the children's training events provided by Chris Collinge and other training events provided by Peter Ballantine: these are all examples of areas where we are able to do things better together (sometimes things that are not viable otherwise). The Week of Accompanied Prayer is now being taken up elsewhere, and this year is being run in Woodhill Prison, an example of what happens in the SEP having a wider impact.

That synergy of pooling energy and skills can help us serve our community better. Over the last year the Partnership contribution to the MK Soup Run has increased from one to two evenings. The Monday and Tuesday runs are sponsored by SEP and made possible by the commitment of people from different parts of the Partnership working together, and working together with people from other churches too.

This year saw the first edition of NETwork, a Partnership magazine produced not 'for internal consumption' but to be distributed, and hopefully enjoyed, on a wider scale. The quality of the first edition made a favourable impression. Now we are working on a second edition, and also on plans to generate some income from advertising. This first production of NETwork came on the back of some fine work to establish a Partnership website as not just a means of sharing information, but often as a first point of contact with our churches in this age of the internet.

The ministerial team is another area of Partnership life where we seek to support one another. Judy Rose has been an integral part of that team for longer than any other member. With the need to make space to be able to care for different members of her family, young and old, Judy felt the time had come to retire as a member of the team. We are so glad, however, that she will still be part of our fellowship and will hold 'Permission to Officiate'. Last summer we said goodbye to Dave Bell, who served as part-time assistant curate at St James. He is now very busy as full-time Team Vicar in the Watling Valley Ecumenical Partnership. Soon after saying goodbye to Dave, we were delighted to welcome Liz Baker as associate priest licensed to the parish. Liz is Director of the Well community and her main involvement is at St Mary Magdalene, Willen.

This time next year we will have said our goodbyes to Chris Collinge who has set May 2012 as the beginning of her retirement. Chris' departure will be a loss not just to St James but to the parish, and it is highly unlikely that this time we will be able to appoint a direct replacement to this post. This raises important questions about the future. Work has already begun on the thinking we need to do, not least in the working group convened by our Lay Chair Mike Morris.

The coming year will be an important time for us to listen to each other and listen to God, as we look to the future and do so with hope and vision.

Treasurer's Report

January - December 2010

The year ended with a deficit of £8,790 however this was considerably less than the budget deficit of £19,000. This was helped by the generosity of at least one of our churches with an additional payment to the Partnership. The share to the Mission Partnership whilst increasing by approximately £9000 was paid on time and in full without any problems.

The transfer of Soup Run Donations to the Partnership went without too many difficulties and is well supported due to the generosity of many small givers across the Parish.

Other income/expenditure was largely in line with the budget.

2011 is again likely to be a challenge for us financially and once again a deficit budget is being presented. This is largely made up of an increase of a little over £8000 to the Mission Partnership, (however as a Partnership we do not come anywhere near the self–support which is being encouraged), payment for the 'Network' parish magazine and membership of Citizens MK.

The generosity of our churches in what they have offered as their share towards the Partnership has helped offset the deficit however there is awareness of those who are struggling and who are not able to give more.

The rate of the Gift Aid revenue refund will be reducing this year, as the Partnership benefits from this, treasurers / gift aid treasurers may have their work cut out to encourage both an increase in giving to cover the shortfall during the current constrained times and also to persuade those who are in work and paying tax to gift aid where possible.

An issue which we will have to grasp within the next couple of years is that of a shortfall in the Baptist Union Pension fund and the need to make this up is coming from the Government. It is likely that there will have to be an increase in the contributions paid to the pension fund of between 6-8%. It is also possible that we may have to pay additional contributions as a result of a 'cessation event' since 2005 (between John Bernard leaving and Chris Howden's arrival). A consultation is currently in place and we will have to wait and see the outcome of this. There is an opportunity for us to have a say in this the end date however is before our next SEP meeting.

I am once again very thankful for the help and hard work given by Adrian Prisk, Paul Watt and Gary Farnes in pulling together the 2010 accounts. Thanks also go to each member of the churches who gives so generously to enable with God's help the work of mission to be carried out in the Stantonbury area.

Accounting Policies Stantonbury Ecumenical Council

The accounts are compiled on the "going concern" concept. This means that all transactions have been made on the assumption that Stantonbury Ecumenical Council will continue into the future

The "accrual concept" has been applied to transaction values, except Gift Aid and Grants. This means that where goods or services have been received but have not been invoiced in the accounting year the accounts include an estimate of the value of the transaction as though an invoice had been received.

In line with the Charities Act three Fund classifications have been used. They are:

Unrestricted Fund This fund contains all values which are for general use within the funding of the Church. The majority of transactions fall into this category.

Restricted Fund This is for monies which have been received or put aside for a particular purpose, for example, 10% of giving for external causes, collections for specific named causes, specific donations or legacies

Endowment Fund This is where investments have been left to the Church and the income is to be used within the Church. In some cases these can also have restrictions as to their use.

To retain an open book approach and to show the size and scope of transactions the netting of costs with income has not taken place.

Children and Families

Much of the work during the year was concerned with adopting the new Vetting and Barring legislation that, in the event, did not largely come into practice because of the response of the coalition government. I also continued with the outreach events to children and families which were available throughout the partnership.

Safeguarding

This has meant that we must apply for each CRB through the Methodist church. However, the Oxford Diocese will still be available to offer advice. The Local Authority Designated Officer, who must be involved should any safeguarding incident arise, give excellent guidance and advice.

Safeguarding Training

No training events have taken place because we were waiting to respond to new legislation.

I was able to attend a training day run by Milton Keynes Council on Safeguarding. It was good to share experiences with a wide variety of people —for example social workers, police and teachers.

Outreach Events

On October 30th we held another very successful Glow in the Dark party. Thank you so much to all of the people from through out the parish who helped at this event — and for the children who came!

Partnership wide activities

There is a diversity of work with children throughout the parish. Young church groups are flourishing at St Andrews and Bradwell Church. St Andrews continues to be a beacon for Godly Play. Cross and Stable are holding activities for children on a monthly basis and this is going well. Christ Church continues with its After School Club meeting every week and more children are coming along to enjoy the activities. St James now has Dolphins each Sunday in church - it is good to be able to offer visiting children some special time. St James' also held a very successful Messy Church on a

Saturday morning and intends to run these at regular intervals. Bradwell has a flourishing Toddler group and Tiddlers at St James is flourishing. A summer school was shared between St Andrews and Christ Church. St James had a well attended week of activities during the summer holidays on the theme of "Fun and Friendship." Good Friday workshops were held at St Andrew's and St James' churches.

The Wider Scene

The Core Skills training event is drawing to a close. It has been an excellent course beautifully presented. The subject covered during 2011 have been Children and Community, Pastoral Awareness and Children 's Spirituality to be held on May 21 St The course has been very much appreciated by the attendees. Unfortunately many of those who work with our children in church do not have the space to attend extra training so the course will not have a direct effect on work with children in the Stantonbury partnership.

I have continued with my involvement with x — site and it is good that some children from our partnership attend and, in some cases, bring along their friends. The team continues to be organised from Scripture Union but consists of members from all over Milton Keynes. The core leaders are Alan Carter (Scripture Union), Rachel Foster (MK Bridgebuilder Trust) and Mandy Eyeington (New Life Wolverton) who are an inspiration — the story telling, music group and general engagement with the children is second to none.

The Future

A Noah's Ark party is planned for June 11th at New Bradwell Community Centre and there will continue to be outreach events and children's activities throughout the partnership. One very exciting development is St Andrew's is holding a quiet day for children using the garden and Godly Play, on May 21st~

I will endeavour to hold some gatherings where our children's leaders can come together and share ideas. There will also be some Safeguarding training held during the year.

I will attempt to keep the website updated.

Christ Church is re-launching an Art group on Thursdays beginning on 19th May from 1.30-3.30, which we hope will draw in people of all ages and abilities and maybe organise some week end workshops. Please pass this information to anyone who would be interested. Other ideas always gratefully received!

EVANGELISM ENABLER REPORT

New House Visiting

After a slow-down in the building programme in 2009/10 there has been an acceleration over the past year in the developments at Stantonbury Park (now to be named Oakridge Park) and Red House Park. A considerable number are now occupied. The Red House Park visiting has been looked after by St Andrew's, while the Oakridge Park visiting has remained a team effort. The visiting has continued in two ways: delivering the Welcome Pack personally to new occupants where we find them in, and delivering Christmas leaflets and the NETwork magazine through doors to every house. A brief word about the materials: the Welcome Pack was designed to be easily updateable. This has proved a good plan as information is soon out of date, and the inserts were all revised this autumn. NETwork was designed to be attractive and useful for a wide readership. Simple features like the list of churches on the back proved useful in doorstep conversations. In the next edition we plan to further improve this feature with postcodes and corrected information.

Christmas and Easter Cracked

In the autumn I stood down as trustee of Bridgebuilder, having served in that capacity for some time and having felt for a while that I needed to try and make some space in an overcrowded diary. I remain as enthusiastic as before about the work of Bridgebuilder. Chris Howden and I recently attended an 'Easter Cracked' session put on by a team from Whaddon Way Church. These programmes are now hosted by a number of churches around Milton Keynes, with support from Bridgebuilder, and are very popular with the schools who bring their Year 6 children to learn in a very interactive way about the true meaning of these festivals. Chris and I would very much like to explore the feasibility of us offering 'Cracked' to schools within our Partnership.

More Than Gold

This is an organisation sponsored by a wide range of denominations and mission agencies to help and resource churches to engage with the London Olympics in hospitality, service and

outreach. We don't yet know whether Milton Keynes will be directly involved in any way in 2012, but we know that the impact will be on all of us.

I am meeting with a small group of leaders and members of different churches around Milton Keynes to explore how we can benefit from 'More Than Gold' resources and work together to engage with London 2012.

Alpha

Once again three courses have been run over the last year, and one is about to begin. The two autumn courses (one held in the evening and one in the morning) both started late, as participants were away or unwell at the time the courses were scheduled to start, and so to complete the courses they both continued over into the New Year. They were both small but proved very worthwhile for those who attended.

Alpha MK has ceased to function as an active body over the last year, so we are no longer able to link up with other churches running courses concurrently.

I have generally offered a follow-up course in the New Year. This year for the first time I used a course called 'Challenging Lifestyle' based on the Sermon on the Mount. The first series (of three) ran up to Easter. It was opened up to whoever wanted to come and had a good take-up. By popular demand we will be doing series 2 during this summer term.

Room'na'te

Room'n'ate is offered as an opportunity for men to meet, enjoy each other's company and also engage with issues of life and faith, often through hearing people's story. This last year we have had some good evenings (including one where members had 3 minutes to give potted highlights of their life) and one or two disappointments too. Our first planned speaker evening was with Andy Stockbridge, Chief Executive of Toybox, who spoke engagingly on the journey that brought him to his current role. Our Autumn speaker evening was sadly cancelled. It was a tough call, but with a speaker travelling some distance and hoping for a group that would include invited guests, we had to make a judgement that we weren't on target for numbers. Roy and I are exploring how best to plan our future programme.

And finally ...

Police Chaplaincy

I have recently made moves to try to develop this role, having found very little time to do so for some time. However, with cuts impending and changes ahead, I believe this may be an important time for some chaplaincy to be offered.


CMA (Christian Motorcyclists' Association)

Minister's Report

I find the word 'Faithful' a thought-provoking one. You'll find it used lots of times in both Old and New Testaments. It's used to affirm individuals (like Tychicus, for instance: "the dear brother and faithful servant in the Lord"). We're called to be faithful ourselves and we're reminded that God is faithful.

I turn the word around in my head and think of it in two ways: faithful as in 'reliable', 'trustworthy', 'loyal'; and faithful as in 'full of faith' – trusting in God, willing to see where He's at work and to step out in obedience where He calls me.

At my core I want to be faithful, and I'd be more than happy if ever I could be described with the words Paul uses of Tychicus (in Ephesians 6).

Being faithful can be tough when the going is tough, but it's a word and a thought I also find helpful and important in those times. Speaking personally, and being honest, there have been times over the last year when I have found the going tough. There have been issues I've needed to grapple with in my role as Team Leader. There have been some demanding pastoral situations, some sad, some difficult. After a number of years when we've seen numbers grow slowly but steadily (both in membership and attendance at services) these numbers have not grown over the last year.

There are pressures 'out there' at the moment which are affecting lots of us – pressures on budgets, on jobs and so on, and many have faced family and health problems too.

So I've found it moving and encouraging to have witnessed people being faithful to God and faithful to each other, and I'd encourage you to be 'full of faith' too, in the way I've described above. I'm also deeply grateful to those who serve faithfully in lots of different ways, as officers, for instance. A lot of these areas of service are covered in different parts of this report, some not (for instance Douglas Stewart's work to produce the noticesheet and John Trippett's work to put out the Sunday rota). I warmly commend this collection of reports to you as a picture of our life as part of the 'body of Christ'.

A key expression of that life is in our Sunday worship. Some of the time we have followed themes in our Bible readings from the season in the church's year, or the lectionary, or S.U. 'Light' material. Sometimes we've done something different. Over the summer we looked at some of the 'Feasts of Israel'. In 2011 we've studied the Sermon on the Mount and are now continuing with Matthew's gospel as we head towards the climax of the story in Jerusalem. Visiting speakers for our 9.00 am and 10.45 am services have included Geoff Colmer (Regional Minister of the Central Baptist Association), the Rev. Dr. Gnanavaram Masilamani (Principal of Tamilnadu Theological Seminary), Kathy Pinsent (CMS link) and Andrew Cowley (CPAS Leadership Development Officer).

An important new part of our Sunday worship has been the (roughly) monthly evening services. There's been a good attendance at these and several have been led by church members: Joanna Hollins, Anne Taylor & Karen Ho, John & Muriel Moffoot, the Lighthouse team. Each service has been unique. An even newer addition to Sunday has been the 'half-hour of prayer'. Lesley mentions this in her report. Sometimes

prayer has been silent, sometimes spoken, sometimes with a background of music. It's a time to bring to God the needs of our fellowship, our communities and our world, and the week ahead.

Since the last AGM I have fulfilled my intention of stepping down as a trustee of Bridgebuilder. I remain a keen supporter of Bridgebuilder and am wanting to explore with Chris Howden and others in the parish whether we could work with Bridgebuilder to offer their Christmas Cracked and Easter Cracked programmes (for children in Year 6) to our local schools. If we did this, we'd need to build a team of people to do it. (Hard work but fun!)

I continue as a Governor at Summerfield School and as Hon. Sec. of the Memorial Hall, and have also been co-opted onto the Robins (Sure Start) Centre advisory group. To my sadness I have found very little time to do any voluntary police chaplaincy over the last year. I hope I will be able to do more. I am also a bit excited about the formation of a new Christian Motorcyclists' Association group meeting at Jack's Hill Café on the A5 and building good relations with the local bikers' community. I will not find time to be a full member, but hope to be an associate.

I feel very fortunate to be made welcome in the local schools, where the main contribution I'm able to offer is assemblies. The children are very responsive and often thoughtful too. I also continue to offer regular services in our local sheltered housing. In addition to the Christmas services and in response to a request from residents, I have started a simple bi-monthly service in one with hymns (with the help of Muriel at the piano). Sadly this has met with hostility from some residents, which has discouraged others. I'm reminded that hostility to Christ and to faith can be found as much in the older generation as in any other.

Which brings me back to Ephesians 6: "Be strong in the Lord and in his mighty power ... be alert and always keep on praying for all God's people ... Peace ... and love with faith ... and grace to all".

Church Council

Council members elected and serving this year have been Claire Meakins, Diana Stammers, Henry Dougherty, Karen Ho, Lee Michalke, Peter Lazard, Pam Watson, Sue Bertrand and myself, along with Treasurer Michael Squire and Church Officers Alan Howarth and Paul Watt. Arthur Georgestone has joined us ex officio in his capacity as a clergyman with permission to officiate and Mike Morris continues to join us also in his ex officio role as Local Preacher in membership at Bradwell.

The first Council meeting following the last AGM was in May, when we confirmed appointments of postholders in various areas of service and fulfilled our requirement to look annually at the Safeguarding Children policy, as well as tackling what is the regular part of the agenda at all our meetings - hearing how the various groups that make up our church life are developing. Reports from each of them are in this booklet. Andy's report is always a key item for us and helps to highlight

priority areas. We have done our best to provide an appropriate steer for him.

At our next meeting in July, we were visited by the Revd Stephen Mosedale who told us about a pioneer ministry, VentureFX. This is a national project of the Methodist church, linked to the Fresh Expressions initiative which exists to allow new forms of church to develop and express themselves in non-traditional ways. The aim is for 20 pioneer ministers in 20 locations over 4 years to minister with the 18-35s age group; the plan was to bid for one location to be Milton Keynes. We have since heard that this is going ahead and a suitable person is being sought.

At our October meeting, Paul Brookman (one of our SEC representatives) joined us to discuss another initiative. Citizens:MK is a community based organisation which hears the concerns of parts of a local community and campaigns for positive change. Citizens:MK was looking to start in Milton Keynes, testing to see if there was support from collective bodies, including faith groups. SEC wanted to go ahead as long as individuals and churches within the parish were enthusiastic. This has now started to function here.

Our final meeting of the year in January saw us concentrating again on the 'normal' business of the church, including reviewing its past activities, and considering future plans. One significant decision was to move the prayer half hour to a Sunday evening from a Monday morning in the hope it would be accessible to more people.

Finance seems always to be a concern to us; we remain grateful to God for the generosity of individuals that means we make it to the end of the year!

The Standing Committee consists of minister, lay chair, treasurer and a representative Church Officer, and meets between Council meetings to move forward details of business as delegated by Council. It has looked at details of finance and recently reviewed our mission giving, preparing a proposal to go to the first meeting of the next Council when elected.

Our thanks go especially to Karen Ho, Peter Lazard and Pam Watson who have completed their various current elected terms of office.

Occasional Offices

2010 was a busy year for weddings at St Lawrence: there were 13 weddings and 1 service of blessing after marriage. 2011 looks like it will be a quieter year, with rather fewer booked as yet, though there are several 'in the pipeline' and several already booked for 2012. Wendy Hanson continues to serve as verger and Janet Edsall as our regular organist. Many thanks to Carol Foster who has acted as clerk to the registers for many years and done an immaculate job. Carol is now passing this baton on to Wendy.

These occasions are of course full of meaning for the people involved, and the contact with the church, both before and after as well as at the event, can be meaningful and important too.

I try to help the couples prepare not just for the day itself but

also for building a strong and good marriage every day. To this end I run marriage preparation courses at St Lawrence for the Partnership as a whole.

On 11th February 2011 (near to St Valentine's Day) we repeated the Marriage Celebration Dinner we tried for the first time last year. I was delighted that several of the couples married recently at St Lawrence came, and thoroughly enjoyed the evening. A kitchen team, which included Ray & Jill Scoins, laid on a 3-course dinner. The clergy and others dressed in 'black tie' to wait at tables and visiting speakers Gary & Jan Palmer gave a humorous and thought-provoking presentation.

The number of baptisms in 2010 was quite low: 5 children and 1 adult (Andy Strickland). In some ways I'm not disappointed by this. Although the sacrament of baptism is for me potentially among the most moving and important and exciting of events, I think I'd rather people didn't do it that did it carelessly. Interestingly we had rather more Services of Thanksgiving and Blessing for children. There were 9 children brought to church for this simple service, happening on a Saturday or Sunday afternoon, often with the church filled with family and friends. Dawn Viccars and young Antony have been faithful helpers on these occasions.

Although we haven't in recent years ever hosted a Believers' Baptism & Confirmation Service (because of our small size and lack of baptistery) I'm always delighted that lots of the church family make a priority to support our candidates when they affirm their faith. This was again the case at the service in November at the Cross & Stable Church, Downs Barn, when Nancy Grisley, Andy Strickland and Mike & Sheila Crome were confirmed. Our Bradwell Church music group provided wonderful music for this event.

Part of the staple of my working week is often to visit bereaved families and to assist them with the funeral of a loved one. In 2010 I conducted 34 services at the Crematorium and there were 12 services in church. At most of the latter Mavis Tunney assisted as verger and Janet Edsall as organist. There is quite a bit of discussion in some circles and some concern that Christian ministers are not being approached to take funerals and that they are often being taken over by 'civil celebrants' and others who make their living by doing them. In my case I find that the number I take does not appear to have reduced, maybe in part because over the years one builds relationships with families and individuals. The relationship may be very slight but can be important at times like this. There is often important pastoral follow-up after a funeral. I find my time capacity to provide this is often much less than I'd like. I'm grateful to Pam Watson for the task she's taken on to write cards to families on the anniversary of a loved one's death.

Bradwell Church Fabric Report 2010/2011

St. Lawrence Church

Quinquennial:

We have instructed our architect to progress the outstanding repairs to the tiles and lead on the roof. These are low priority repairs that are not expected to cost very much.

Damage and repairs:

The Baily burial crypt in the south east corner of the church that had collapsed in 2009 was repaired in accordance with our architect's instructions. The work was carried out in May/ June (by Steven Todd of Earls Barton, Northants) and the site returned to the condition it was in before the collapse. Rather than reinstating the brick vault, which will never be seen again and would have cost vast sums of money, the chamber was roofed over with concrete beams. The rubble that had fallen into the crypt was left in situ. The three coffins were undamaged and left in place. Contrary to our original expectation, the cost of this work was mainly covered by our insurers.

The drop-bolt keeper plate of the church gates that was damaged by a motorist driving into it was repaired in May/June by Lavendon Building Co. Ltd., of Risely, Bedford. The cost of the repair was covered by insurance, with a small cost to ourselves because we modified the design to prevent a recurrence of the accident.

Electrics:

A working group has been formed to consider different aspects of the proposed new lighting for the church.

New additional speakers have been ordered for the south aisle and it is expected that these will soon be installed. The new speakers will fill the acoustically 'dead' area in the aisle.

Plumbing:

The tap in the kitchen needs replacing as a result of corrosion damage to the spout, which now leaks when the tap is running. Unfortunately this is not a conventional kitchen tap and the work will need to be carried out by a qualified plumber. This outstanding work will be done early in the next year (hopefully in April).

Fire Extinguishers:

The fire extinguishers were checked by 'Nu-Swift' at the end of September and as they were found to be in a satisfactory condition we were given the relevant 'Portable Extinguisher Maintenance' certificate.

Changes and Additions:

A small brass bolt was fitted to retain the servery shelf in its down position to prevent it from obstructing the kitchen door.

We were given a number of nearly new stacking chairs with fabric seats, which will be used as additional seating in the church replacing the much older chairs with the solid plastic seats

New carpet tiles were laid in the vestry.

Church Cleaning:

A small team of regular volunteers with occasional help from others have succeeded in keeping the church clean and presentable all year round. It goes without saying that this is an important job and we need to keep a rota of helpers to make sure it is done regularly. Without this people are often forced to step in at the last minute before a wedding or funeral to make the church appropriately clean and tidy. With enough

names on the list the burden falls only a few times a year so it need not be an onerous duty, but there are people on the list who have been on the rota for a very long time and it would be nice to give them a break. So please consider whether you would be able to spend an hour or so every couple of months and let me know before the new Rota comes out in May.

Churchyard:

The church notice board was treated in March (2011) with Sikkens Cetol THB 006, as recommended by the suppliers to protect it and to retain its golden colour.

Work has started on the preparation of a submission to the Diocese for a faculty to erect cycle racks adjacent to the annexe door. These are likely to be steel hoops (stainless steel or galvanised) in a 'toast rack' form with capacity for six bikes. The funds for this are already being held in a restricted account so we are not expecting any impact on our annual budget.

Lawn mowing was again contracted out to our regular contractor and all strimming. We are grateful for the help with strimming given by the Parish Council through their groundsman and to all the volunteers who have helped maintain the churchyard. Particular thanks are due to Richard Beaton for his help in mowing the extension area and to Dick Grace for mowing in front of the church.

Back in July we had a Working Party day and tackled a number of jobs within the church and churchyard: -

- Cleaning of gutters and gulleys.
- Clearing of weeds from the childrens grave enclosure
- Clearing of weeds from around box tombs
- Treatment with weedkiller
- Lopping and pruning of yew and holm oaks
- Rehanging of annex door that had dropped slightly
- Painting of gates (using Spencer PU100 Enamel Semimatt black, which was provided by the gate restorers, Anwick Forge)
- Painting of toilet: white ceiling, magnolia walls
- Deep cleaning of church, especially kitchen

We are planning more working party days; in April (02/04) and, for a late summer-clean, in September (24/09). Please help if you can.

Bradwell Chapel

The rendering to the wall at the rear of the building was repaired (Timeline Plasterers) and the 'low level' electrics rewired (Phil Wood). We are grateful to the Methodist circuit who contributed £1000 towards the cost, which was added to money raised at the Memorial Hall Spring Fayre (£75).

We had a gift of carpet tiles which were laid in the summer by Alan Howarth.

The Chapel is the home of TWIG, our young people's 'house-group', and is used for various meetings both for Bradwell Church and for the parish. It is hired out on some occasions for use by other groups. There is capacity for increased usage. The Chapel is also an invaluable site for our photocopier and some other church equipment and resources.

It remains a 'place of worship' and so its use needs to be in keeping with this. The Monday early morning prayer time (in the Chapel) has now been replaced by the 'half-hour of prayer' on Sunday evenings (in the church) and we may wish to think about how the Chapel could still be used for prayer and worship.

Thanks and Appreciation

Our thanks are due to Tony Trigg who obtained the good-asnew chairs and carpet tiles for us, and to Alan Howarth for fitting the tiles. Without the help of our band of volunteers it would not be possible to keep our church looking as beautiful as it does. The appearance and condition of the church are a real asset to the village and a credit to our Christian faith: our gratitude goes out to all those who have helped to keep it this way. As ever, if you would like to join the Fabric Action team, help with cleaning duties or help out in any other way, please do let me or one of the church officers know.

This subject brought many memories to the fore from each of us and we feel that we dealt with past hurts and are now able to go forward.

For Lent the group is studying 'Jesus' Final Week'
by Cindy Bunch (Scripture Union), meeting weekly
through Lent in order to finish the study in Easter week.
The book examines each day in Holy Week, and hopefully it will give us a clearer understanding of the path
to the Cross.

It is still £1.00 to attend our housegroup! The community projects we have supported / financed in the last 12 months are:-

- Two boxes of knitted hats and jackets for children sent to Africa.
- Second hand Dyson upright hoover for Bradwell church
- Donation of £50.00 to Climb Your Mountain Charity, sponsoring the granddaughter of one of our members, who was climbing Kilimanjaro in memory of her grandfather – she made it to the top!
- £25.00 to Plough Publishing House who send out 'Why Forgive' by Johan Arnold for free to prisons, secondary schools and study groups.
- £36.00 to a fund set up in order to buy a Salvation Army uniform for a 17 year old girl whose parents could not afford the uniform.
- As a group we volunteered to run the annual cream teas
 pulling in some extra hands to help!
- 16 carrier bags at Christmas for 12 men and 4 women given out at the soup run for the homeless in Christmas week containing 24 useful gifts.

We pray that the Thursday evening housegroup will continue to flourish and that God will be present at our meetings, guiding and teaching us to understand the Bible more clearly and to remember those who are in need.

Stantonbury.net and NETwork

After years of discussion and good intent the past 12 months has seen the launch of two long awaited projects – the Stanton-bury Ecumenical Partnership's website at www.stantonbury. net and the first edition of NETwork, an occasional magazine for the partnership.

The website went live last spring and is steadily growing although we still need to get congregations into the mode of "think event, think web" as the supply of information and publicity for events happening in the partnership is still sporadic.

Nevertheless Stantonbury.net is proving a valuable tool to bring together the six churches in our partnership area with easy access to information and goings on in other churches, in particular the weekly notices.

Traffic is steadily building but it is imperative that we are able to regularly update the content to encourage visitors to return to the site frequently.

NETwork is the name given to the partnership's magazine for all our churches. How was the name chosen? Well the NET part of the title refers to North EasT Milton Keynes – the Stantonbury partnership area.

As the first magazine was very much an experiment with no date set for a follow up issue it was decided that the content would be mostly feature based so that it did not date too quickly. It is also being used as a tool to drive traffic to the website where current events can be publicised.

We are already in the early stage of planning the next issue of NETwork – Stantonbury Ecumenical Council has authorised the funding for a magazine to be published in June but we hope to offset the costs by including a limited amount of paid for advertising. Milton Keynes Soup Run

Bradwell Church is now fully involved in being part of the Milton Keynes Soup Run for the homeless and needy, both on Monday and Tuesday evenings.

Some members of the Sunday night housegoup expressed the desire to demonstrate our Christian love for others in action and so we began to investigate whether we could support the soup runs already being led by Woughton Ecumenical Partnership (Wednesday and Friday evenings) and Stantonbury Ecumenical Partnership (administered initially through St James' Church, New Bradwell for Monday evenings).

With much help from those teams we eventually gathered enough volunteers to get our project off the ground – to deliver soup and sandwiches on a Tuesday evening.

We hand out soup and food at three venues at pre-determined times at Milton Keynes Central railway station, Milton Keynes Theatre and Milton Keynes Library.

It has proved to be an interesting and worthwhile experience, hearing the stories of those we serve and how they came to be in the situations they are in. Some are genuinely homeless while others get by sleeping on the floor or sofa in the homes of friends but have little funds for food.

The key aspect is that we do not judge people by their circumstances and nor do we preach the Bible. Rather it is by showing our love for our fellow human beings that we pray that one day they will find it in their hearts to seek the love of God for themselves.

The further good news is that although the Tuesday soup run was the initiative of the Sunday housegroup it now makes up less than 50 per cent of its membership – with other members

coming from this church's congregation and other churches in the Stantonbury partnership.

Mission Giving and Mission Prayer Focus

Each month we focus in our noticesheet and in our intercessions on a mission enterprise which we support through prayer and financial giving. Some of this giving is through our 'tithe': we follow the principle of giving 10% of our regular income

to mission causes. Some of these are local, some national and some overseas. The amounts (and the causes) are decided by Church Council. We don't aim to change the allocation a great deal from year to year, as regular, reliable support is so often important for the causes we give to, and it can take time for us to get the word out about them. We want the support to be about much more than money, and to be also about prayer, awareness and sometimes action.

Lesley Blight has prepared a brief summary of our monthly focus, which I'll include here as it's very helpful (see overleaf). Over the next year it may be helpful to refresh the way we keep informed and prayerful about these causes. Each Mission Focus benefits from a 'champion' who will promote awareness.

The tithe amounts given in 2010 are listed below, together with the projected figures for 2011. We did a great deal a couple of years back to 'catch up' with our tithe giving. We have fallen a bit behind in terms of the total given as a proportion of what is now our regular income. The Standing Committee looked at this and drafted revised figures for 2011. Our policy has been that if we find our actual tithe figure exceeds the planned giving, we set that amount aside to respond to emergency needs worldwide.





Minutes of the Annual General Meeting of The Cross and Stable Church

Held on Sunday 7th March 2010

1. Apologies for Absence

2. Previous Minutes

The Minutes of the Annual General Meeting held on the 29 March 2009 were agreed and signed. There were no matters arising.

4. Annual Reports

All the reports for 2009 had been circulated beforehand. Thanks to John Wheaver and Peter and Gwen Green for assembling, photocopying and stapling them. They were agreed.

5. Financial statements 2009

The accounts were accepted subject to the approval of independent examiners; proposed by Bob Cross and seconded by Joan Wilson. Gill was thanked for all her work as Treasurer. Willen & Downs Barn Minister's Report 2010 - 2011

Over the last year I have continued to try and develop the joint role of being Minister with pastoral charge of both churches within the Stantonbury Team, combined with being Team Rector (which, in effect, is a minor role). As Minister of the two congregations my emphases in the past year continued very much as detailed in previous reports.

The main points to note over the last year include:

At Cross And Stable

- Continued decline in the number of people attending Cross & Stable church for a variety of reasons including removal from the area, frailty, and some significant deaths
- Increasing pressure on fewer individuals helping to run the building
- Recent initiatives have included:
- raising our profile: we are pleased that the building now
 has a visible name on the exterior and are grateful to the
 Management Committee for doing this; Christmas advertising was well received and we are grateful to those
 individuals who took initiative and made arrangements
 for a striking handbill and poster design.
- running an experiment with the arrangement of our seating and concluding with a modified form of our habitual Sunday morning shaping. This was a result of our Thinking Morning and resolving to run an experiment.
- Planning four quarterly evening services in Cross & Stable for the whole parish
- The monthly services for the deaf have continued to be well attended and the signed carol service was successful again. Informal carols were well-attended and is becoming a fixture
- Agreeing a significant decrease in our contribution to the parish share.

At St Mary Magdalene

- Continuing to care for the building and its fittings in various ways: most recently, improving the wood panelling (an ongoing task) and upgrading the PA system.
- It is hoped to bring mains water to the exterior of the building during the coming year.
- The licensing of Rev Liz Baker, a former member of the congregation and now Leader of the Well at Willen, as an Associate Priest in the Stantonbury Partnership. Margaret Moakes continuing ministry as Licensed Lay Minister (leading worship, leading small groups and in pastoral care and spirituality for others)
- Working with the Well in mutually enriching initiatives, including continuing a monthly healing service in church
- Enjoying some social and fund-raising occasions for general fund raising
- Continuing occasional interfaith meetings: Jewish and Muslim so far.
- Celebrating a significant increase in the number of weddings in 2010 and providing

- marriage preparation using resources and personnel from our own congregation.
- Building on the success of choral evening services with Quorum as part of whole Partnership pattern of evening services throughout the year.
- Visit to Westminster Abbey involving members from around the Partnership.

Generally

- Continuing a Christian group at the new Lovat Fields Retirement Village ("The Tree of Life Group"); wellattended Christmas carol service and Remembrance Day services
- Continuing with local schools, recently adding Brooksward to the schools I visit
- Occasional chaplaincy cover at Willen Hospice; weekly prayers with chaplain.
- Welcoming some visiting preachers at both churches during the course of the year and having members of the Stantonbury Ministers Team visit to take services from time to time.

Challenges, Opportunities And Issues Which Face Us Are:

- Continuing to define a clearer relationship between the Well and St Mary Magdalene Church and promoting consciousness of that
- Meeting our responsibilities of care for the upkeep of both buildings through volunteers
- Pastoral care at both churches
- Supporting the parish share and other charitable causes through our giving.

The Church of England has appointed two Church Wardens to that Parish and decreed that wardens of Congregations shall be described as Deputy Wardens. The Council has pointed out that Officers of any Congregation may call themselves what they will so we are sticking with Warden.

It's been a busy year and our first concern is that worship may take place and this is easy because of the helpfulness of all the Congregation who come to Church and get on with what ever task may present itself. I am also grateful to the Stewards, Readers, Servers at Communion and the coffee makers who ensure week by week that our services take place.; in our helpers we are blessed. Behind the scenes there is the secretarial work and the rostering of duties together with the preparation of he communion table – all performed by volunteers who deserve our gratitude.

The other main concern is the numbers of our membership, which have now reached the smallest they have ever been. The Stantonbury Partnership have listened to our concerns and responded with practical help in that they have reduced their financial demands upon us and, spiritually, have started to look at other ways we may be helped. An evening service on Sundays, once a quarter, is a start. We continue to pray for guidance and an increase in attendance. Please let the Officers know of any ideas you have.

Highlights of the year have included the Parish Ecumenical confirmation service held at the Cross and Stable and the always amazing service we hold each year at the Tree Cathedral. It is always a pleasure when the occasion demands that we share our worship with our brothers and sisters at Willen either here at the Cross and Stable or at the newly re-roofed St. Mary Magdalene Church

My personal thanks go to Our Vicar, Paul and all those who help in our worship.

Report from the SEP Representatives for 2010

2010 was the year when Stantonbury Ecumenical Parish changed its name to Stantonbury Ecumenical Partnership. This reflects the desire of many members that the Partnership should be seen as a group of ecumenical churches. However for Church of England purposes it is still called the Parish of Stantonbury with Willen. As an Anglican Parish it must appoint just 2 Church Wardens, however many churches there are in the Parish. Each Church can appoint its own Officers. In 2010 the Wardens for SEP were Bob Cross and John Figg (Willen).

In 2010 there was an Evening Service every Sunday somewhere in the Parish, including, in July, our Tree Cathedral Service.

The Soup Run for homeless people has been extended to include Tuesday evenings. SEP is now responsible for Mondays and Tuesdays.

New Bradwell Methodist Chapel has been sold to MK Tabernacle. The formal Sharing Agreement for St James in New Bradwell is still with the solicitors and until this is finalised the Church cannot receive any proceeds from this sale.

The Parish Review took place in 2010. This review should be held every five years to check that the work of the Churches is being conducted in accordance with the requirements of the participating denominations. There was no doubt that this is happening and the report from the Review Panel has been circulated to the Mission Partnership and in our Churches.

There have been concerns about lack of communication in the SEP. To help resolve this issue there is now a SEP website (www.stantonbury.net) and the first issue of a new parish magazine was printed in December (NETwork)

A community Arts Festival was held at Christchurch during Holy Week. This incorporated an art and sculpture exhibition, evening concerts with music, drama dance and song and afternoon craft workshops, all with an Easter Theme. It was very successful involving people of all ages who do not attend church services.

The Well at Willen hosted another Week of Accompanied Prayer in July.

We hope that every Church Member will feel that as well as belonging to their "own" Church that they are also part of the wider Stantonbury Ecumenical Partnership.

Mission Partnership Report

The Review process has continued and an interim body of Trustees has been appointed. It is hoped that all the groups will be in place by the AGM in June 2011. Reverend Dr. Mary Cotes completes her term of office as Ecumenical Moderator of the Mission Partnership this year (2011). In the restructured process her successor will be known as the Director of Ecumenical Mission. A job description is being drawn up.

The Mission Partnership were involved in the Ecumenical

Kirchentag in Munich in 2010. A group from Milton Keynes had a display stand in order to explain the ecumenical story of Milton Keynes. The Leipzig Link flourishes and a small group went to celebrate the 25th anniversary of St Martinskirche.

At the November Assembly Amy Merone from Christian Aid's Oxford office spoke inspiringly about Christian Aid's work in Tajikistan, Central Asia, one of the world's poorest countries post USSR. Christian Aid are helping people to grow food crops instead of cotton - a project called 'Power to the People'.

At the March Assembly Rev Alan Hodgetts, Chaplain of Woodhill Prison spoke with much compassion of his work. Rev Daphne Preece, newly appointed Chaplain to the Milton Keynes Hospital, gave a quick overview of her work with patients, families and staff and is hopeful that more help will be available, either from the voluntary sector, or a second chaplain to ensure 24/7 cover.

We are recommended to attend a service on 15th May at 6pm in the Church of Servant King, Furzton to celebrate the 400th anniversary of King James Bible.

Photocopier

A photocopier continues to be available to church members and other users of the Cross and Stable If you do wish to use this resource please contact Peter or Gwen.

During the year nothing has been spend on maintenance or copy charges and £100 is being handed to the Management Committee for the use of the Snug. All costs for paper and toner have been met from income. All users have paid their bills. Free copies were made available to one user facing financial difficulties. 40,000 copies have been made during the year at an average charge of slightly less that 2p a copy. After paying the Management Committee there will be a balance of £1250.

Despite the high cost of tinted A4 paper (currently £8 for 500 sheets compared with as little at £2.00 per 500 for white) we shall try and maintain the 2p price for all copies.

The present machine performs well and there is no immediate need to change. At only 40,000 copies a year it will be hard to justify a better machine or a colour copier. At the moment good quality laser colour copies can be ordered at 15p a copy. We do hope that for users to have access to a copier on the premises at very low rates is worth the inconvenience of the space taken up in the Snug.

Annual General Meeting 17th April 2011

- 1. Opening Prayer. Peter Ballantine began the AGM with prayers.
- 2. Apologies. There no apologies received or notified. In attendance were approximately 55 people.
- 3. Minutes of last meeting.

The meeting was asked if the previous meeting notes were an accurate record of events A vote taken proposed by Julian Pedley and seconded by David Wilson. Confirmed nem com.

- 4. Matters arising there were no matters arising. PB duly signed for the records.
- 5. Membership role the secretary reported that there had been an increase in numbers. There had been one person taken off the list. The numbers being: Total 120 members -93 Anglicans 6 United Reform 10 Ecumenical 3 Methodist Baptists 4 others 4.
- 6. Finance Louis Fourie produced his report commenting that our General fund ended up with £3100 less than in 2009. Confirming that the Parish share was by far our largest outgoing. As a result of various projects and appeals we have achieved the target of meeting the Parish share. In addition Louis said that St. Andrew's will have to work hard to support projects and appeals to meet our commitments in the future.

Peter Ballantine took the opportunity of thanking Louis and Wanda for their excellent work over the last few years as acting Treasurer for St. Andrew's. Louis and Wanda are emigrating to Australia in June. Copy of Louis's report is attached.

7. Fabric/Building report. This was presented by Steve Hutchings. This included the following points - This last year saw the project for the restoration of stonework in line with the Quinquennial report. With the help of generous donations and grants this work will commence in the latter part of 2011.

The Easter cross has been successfully mounted on the wall of the south Aisle. A copy of the report is attached. SH thanked both David Kent and Derek Clarke for their help with the Cross.

Mention was made that next year SH plans to look at improvements/repairs on the interior of the church. He commented further to state re the Preservation fund that we should not allow to drain it!

Question from the floor relating the departure of Chris Collinge, would this help re finances. PB replied that when Chris Collinge leaves, there will be no replacement and will not have any significant impact on the Parish share as we are not paying our way at the moment. Further comment from PB was that recent changes in tax relief will mean a small decrease in what we claim back.

There appeared during the winter a stain on the side coming from the Church roof which can be removed. Peter Ballantine took the opportunity of publicly thanking Steve for his work for St. Andrew's which does save the church a lot of money.

8. Quiet Garden Report

Submitted and presented by David Kent. David presented his report by saying the Quiet continues to be used by visitors and the congregation. This year we will celebrating the third anniversary of the Quiet Garden. It is hoped that events next year will follow the church calendar.

Details were given of Contemplative Quiet Days held during last year and gave details of forthcoming events for this. He thanked Margaret Broadhurst and David Wilson for the inspiration and help in planning these events. Dates for this year are identified in his report a copy of which is attached.

David Kent presented a report on the <u>Maintenance of the Churchyard</u>. He thanked the volunteers who help at the working parties and also to Duncan, Judy Rose's son who does a first class job looking after the grass around the churchyard. David's report is attached.

Question from Julian Pedley asked about the snowdrops. That when the extension of the grave yard happens this area they would be lost. SH replied that he plans to put discreet markers, within this area which will be resown for grass.

9. Bell-ringers

The Great Linford bells continue to be rung regularly by a core of 7 local ringers supported by regular help from Newport Pagnell and Padbury. On most Sundays we can get all 6 bells ringing for service. We have gained three new recruits in the year, Ryan, Jamie and Viv and all are doing well and making good progress. Alex moved to Nottingham University in the year and has been ringing with the University Society. She was elected their Master in February 2011 for a twelve month term of office. We have re-established a regular eight bell practice on the third Tuesday of each month at Downs Barn, which is good for our ringers and is attracting ringers from other towers around Milton Keynes. We also ring for service there on the first and third Sundays of the month. Alan continues to be the Deputy Master of the Oxford Diocesan Guild of Church Bellringers which involves organizing a few events and attending meetings. St. Andrew's receives regularly visitors locally. Also there is a current objective to raise funds for Bell-ringers by the Quiz questionnaire.

10. Choir report

St Andrews has been represented at each of the Quarterly mission partnership meetings held throughout the past year, the mission partnership forum continues to represent Anglican;

Baptist; Methodist, Roman Catholic & United Reformed and it has been pleasing to see good representation from each of these denominations at all the meetings. The venue of the meetings over the past year have also continued to rotate with meetings held at Christ the Cornerstone; Newport Pagnell URC & Stantonbury. The Mission Partnership assembly has been chaired by Dr Mary Coates as Ecumenical Moderator through the past year but Mary has now tendered her resignation to this post and will be standing down in June pending the appointment of her replacement.

A core element of the meetings over the past year has been based on the changes to the working structure of Mission Partnership addressing it's legal foundations as a result of changes in the operation of charities as overseen by the Charity Commission. The past year seen agreement being reached on the principle structures which will now be implemented over the coming year meaning 2011/12 will be the final year that the Mission Partnership assembly will operate as the new structures will then take over.

In addition to the legal and business aspects of running Mission Partnership meetings held over the past year have also included a number of guest speakers including Christian Aid, Milton Keynes hospital Chaplain plus the Chaplain of Woodhill prison. Meetings have also continued to provide a useful forum for representatives of all the denominations to update the members of the Mission Partnership assembly on topical and newsworthy updates.

Next year will be the final year it will be running in its present format. There will be a new focus.

Judy Rose asked the question in terms of the different format would this have any impact on the monetary giving, answer was it will be the same.

Vicar's Report for Great Linford AGM 2011

Each year special memories stand out and for 2010; Good Friday morning watching Anita's 'godly play' with 36 children spellbound for half an hour. Also was our Christmas services flourishing despite the worst weather for many years or decades.

There are of course many other good memories which makes me proud and humble to be part of St Andrew's church.

So what kind of year was it?

We saw a discernable growth in numbers especially in the second part of the year. It is encouraging that many of these new faces of all ages have stuck with us but of course we must let folk explore church and faith at their speed. Are we getting to know each other and not just talk to our friends lover coffee.

We are seeing some changeover in leadership. Chad had to stand down as LLM during the autumn for personal reasons; we are grateful for his preaching, leading of worship done with a great dry humour! Judy Rose took some time out to reflect on her future and this has culminated in her 'retiring' in an official capacity as a member of the Parish Ministerial Team but she will still be around to help out from time to time for which I am grateful. During the year we welcomed back Glynis in her newer guise of married to Peter Dudeney who as a retired Methodist minister is offering us some help. And we have seen already Glynis' musical contributions!

We have met our financial needs and thanks to Louis and Wanda for their sterling work. We will be sorry to see them leave these shores this June but we wish them God speed in their new life in Australia.

Some challenges

Anita in particular has done great work with the children but sometimes we are getting some 25 under 16s in our services and we need more help. If folk feel a concern to teach our youngsters about the Faith, please consider joining our small group of leaders to work on a rota basis. Some training will be necessary and given.

Freddie and Joyce in particular have given faithful service in being vergers as funerals and weddings. Freddie has now stood down and Joyce needs some help to cover. Any offers?

Finances are always an issue. With the building work this summer, our reserves will be down to a bare minimum and also we really do not still pay our fair share towards ministerial costs. These sadly are unlikely to go down not least as from an Anglican perspective, as the subsidies offered to the 'new town' are now at an end. We will have to pay our way. Could I challenge folk to think through their giving -understand that we are in a recession and that money is tight but

An issue that we will have to face up to in our Partnership is that of ministerial cover; Chris Collinge will retire this time next year and it is unlikely to be replaced (partly financial partly availability). This has implications for how we do 'ministry' and this is more than filing in the perceived 'gaps' - some fresh air thinking is necessary. There is a small task group set up by the SEP on which Adrian Tarr is representing St Andrew's.

It is great to see skills arise in our congregation as people use God's gifting for a wider use; to see Sue Close and Livvy Clarke's musical talents emerge has been a revelation!

For myself, it is worth noting that along with all Anglican paid ministers I went onto a new employment contract this January called 'Common Tenure' which bring us more into line with the kinds of contracts that most of you at work have. It gives us in some ways more security but also our responsibilities and work arrangements are more clearly laid out. It allows me to stay until 70 if I so desire and as I approach 65 I have no immediate plans for retirement.

We must not forget that we work in an ecumenical partnership for which i am grateful'; it is good to exchange pulpits and have the stimulation. The Ecumenical Review highlighted the issues of whether we do most of our services in a default Anglican mode and I am trying to address that and you will notice some subtle changes. I am particularly keen that we have a more regular Baptist input than we have been having.

Mission Partnership has been changing its focus over the last year or so. The new emphasis is going to be less on structural unity but unity in mission. After all Jesus' prayer that we should be one was about a purpose = that the world might believe. It is great that we are Ecumenical but we must never lose our focus that we as a congregation are called to share and live out the Good News of Jesus -that by word, deed and attitude we may commend the Gospel of forgiveness and new life and purpose. One of my concerns is that of what could be called 'secular' man and woman - those who are so far from organised religion and faith in general - those for whom what we do at St Andrew's is such a mystery. Many folk comment on the atmosphere at St A's and that's great but let that be part of the process of a journey to faith for those who join us.

So many people have worked hard - I will mention my colleague David Wilson and my lay chair Nick Bloomfield with whom I have shared many a curry. There are so many of you who have worked hard, creatively and prayerfully - thank you all

The Repair of Saint Andrew's Church

2010 saw the start of the project to restore the exterior stonework, in line with the 2007 Quinquennial Report. The lengthy process of having a Schedule/specification prepared and put out to tender, acquiring a Faculty; applying for Grants took most of the year Thanks to generous donations and the hard work of those of you who have organised fund raising, we have secured sufficient money for the work to commence. Presently we are awaiting a start date from the stonemasons.

I would like to thank David Kent, and Derek Clarke for their help in getting the Easter Cross mounted on wall of the South Aisle. The cross has been successfully used outside at Easter and on Remembrance Sunday.

I have finally completed the repointing of the Ground Gutter that encircles the church - well almost -some repointing to the lower wall on the north side is needed. The Gutter is now watertight which means the walls of the church can now begin to dry out. Since they dry at a rate of one inch a year, no significant difference will be seen for some time.

Finally, over Christmas, the church suffered a leak into the Nave, leaving a unsightly brown stain. This was due to the extreme cold weather and heavy snowfall which created six inches of ice that blocked the gulley. Hopefully the stain will brush off. Clearing the gulleys of snow, insimilar weather, will prevent reoccurrence.

Late morning session particularly arranged for children accompanied by an adult followed by a shared lunch. Anita Bolam has agreed to assist with planning this morning.

Sunday 10th July

Afternoon event 3.00pm to 6.00pm followed by shared tea. This will be the 3rd Anniversary celebration of the Quiet Garden opening.

Saturday 17th September

Morning event 10.00am to 1.00pm followed by a shared lunch. This morning is planned particularly for men.

November Advent Event

ft is hoped to provide a Saturday morning event during this month.

Looking ahead to 2012 it is envisaged to plan events to coincide with important dates in the church festival calendar.

It has been a pleasure this spring-time to see the display of three swathes of daffodils opposite the QG. A further addition to complete the third swathe of bulbs will be planted during Autumn 2011. Thanks are extended for the Social Fund in funding the cost of the bulbs and volunteers who planted them.

Last Easter and again on Remembrance Day & Sunday a wooden cross was erected opposite the QG. The cross was sensitively decorated to enhance these occasions. It is planned to repeat this again this year.

A faculty has recently been granted to provide a lamp post to illuminate the QG and notice board areas. It is anticipated that the QG and Social Funds will provide the necessary monies to pay for this work.

Maintaining the Churchyard Environment.

This work is generally overseen by a group who meet bimonthly, and I thank them all for their commitment. This group consists of Peter Ballantine, Anita Bolam, Kathy Buchanan, Sue Close, Steve Hutchings & myself We meet to plan and assess work that requires attention throughout the year. Any one interested in joining this group would be most welcome.

It is well documented that churchyards which are cared for by its congregation and local community are less likely to be subjected to acts of mindless vandalism. Our general aim here is to retain a balance and variety of areas for wildlife without developing either an overgrown jungle or a manicured garden. Within the existing churchyard area there are two small wild-flower areas, and soon between two of the horse-chestnut trees along the South wall an area for cremated remains will be provided. It has also been satisfying to see how the natural

perimeter boundary hedge to the churchyard extension area is steadily establishing itself Thanks are also extended to Judy Rose's son Duncan who regularly mows the grass during the growing season.

Churchyard working partys have taken place on a monthly basis on Saturday mornings and I wish to thank all volunteers who have given their time and energies. All help is welcome, if you feel you would like to help but are unable to attend on a Saturday morning but are available at other times, please either contact Steve Hutchings or myself and we will be pleased to direct you to small areas of work that require attention. While working within the churchyard one can be pleasantly surprised by the conversations that can be shared with visitors attending graves or seated on the QG benches. This offers volunteers an opportunity to be God's welcome here at St Andrews.

publication and issue/distribution of the first SEP Network magazine (to be followed up by another soon)

the future of paid Ministry in the Parish (a working party has been set up to consider the options and report back (St Andrews were invited to nominate a rep and I understand that Adrian Tarr has agreed to participate)

SEP has enjoined the CitizensMK movement in order to help influence those who might be able to improve low wages and other worthwhile social goals such as temporary housing accommodation for the homeless, tackling drug abuse, facilities for young people, etc)

There were many other events held emanating from the SEP/SEC such as the special review meeting of performance held at The Cross and Stable in January and the celebration of new marriages dinner also at the C&S, in February.

In a nutshell that's it, but I will be happy to address any questions or deal with any further information required.

Treasurers Report

First and most importantly a very very BIG thank you to everyone who helped with the church financeS in 2010. Thanks to everyone who contributed funds, time and support to ensure we meet our financial obligations for the year, specifically:

- Jill Clarke who has done yet another great job of the Gift Aid Scheme;
- Caroline and Trudy who religiously counts the money every Sunday;
- Adrian who banks the money every week for us;
- Kathy who organises green envelopes;
- Trudy who is always there to answer questions and help with year end; and
- Wanda for all the administrative support.

We are still waiting for last years accounts from the auditors, and anyone who wants a copy please let me know.

Our General Fund ended with £3 100 less than in 2009 and our biggest outgoing, as per usual, was the Parish Share. Thanks to various projects and appeals we managed to meet our full Parish Share target of £38 400, up from £36 000 in 2009. The council has agreed to keep the budget at £36 000 as per 2010 and then make a decision towards the end of the year to pay the full share or not, depending on funds at that point.

Even though our total income was £2 500 more than hoped for, we again had to use money from our General Fund, as we had a deficit budget to start off with, and outgoings were £2,300 higher than expected.

We will really need to work hard again this year to meet our targets, so please support all projects in aid of fundraising for the church. This will be the final year that we can afford to have a deficit budget, as the General Fund balance is now only £2 700. There are many things in the pipeline to raise funds for the Restoration Fund, but it must be highlighted that we mustn't forget that Parish Share is our first and most important obligation.

General maintenance around the church is still carried out by the Clarks and the Stephen Hutchings and we are very thankful for this. A big thank you to Stephen and Trudy for all their efforts in securing donations for the building work.



Vicar's Report April 2010 to March 2011

St James' year of celebration is ended although I hope we will never stop celebrating our risen Lord! The sesquicentennial anniversary was a delight full of diversity and I believe almost stress free. That is the way it should be. In my report last year I said "My dream is that during the coming year we will face the future with enthusiasm and create our own vision statement that will guide our future ministry."

My dream has come true. The vision statement is on the front cover of the Annual Review.

The vision statement developed through two particular acts of worship in church followed by some work in a small group. In the acts of worship the congregation worked first of all on identity trying to envisage how others saw us and how we saw ourselves. Two words summed up this initial work welcome and warmth. There was both a desire to welcome people with warmth and a hope that that was how we were experienced in the community. There was a real hope that we are a churchfamily. The second service looked at how we saw our mission. The responses to this were more diverse. Again there was welcome in the sense of inclusiveness and showing the love of God to people through acceptance. There was an appreciation of the church as a place; offering space for prayer and reflection. There was also a desire to learn more, an appreciation of the work of prayer, a valuing of the diversity of worship and a small number of people aware of the need to actively engage with global issues. There was not an emphasis on the Stantonbury Partnership except in the expression of appreciation for the diversity of worship offered through our engagement with four denominations. However, this is an important part of who we are so it was included in the Vision Statement.

The vision statement is illustrated by a tree. The Trinity is expressed through the tree trunk thus illustrating the understanding of the Trinity as being essential to our expression of faith. The boughs hold our main statement which is to be welcoming followers of Jesus empowered by the persons of the Trinity. The tree brings to mind the parable of the mustard seed. It also reminds us that people can come and go always finding a place and that some will simply rest for a while under its shelter. Thank you to Pete Roberts for producing this final illustration.

All that remains is for the statement to be known by all of us so that it can inform and guide our lives as well as make clear to others who we are.

The figures for January to December 2010 are as follows. There were 3 Baptisms and 1 Thanksgiving for the birth of a child. There were 9 couples married in church, 7 funerals conducted in church and 13 funerals conducted on behalf of the church at the crematorium. The average weekly attendance was 46 adults and 7 children.

Some time ago we adopted the rule that limited the number of years a Church Officer could serve to 6 years. Sadly this means that Prue Errington finishes her term of office this year.

Prue has been a rock; her support and wisdom never fail. I shall always remember that she said she felt called by God to be Church Warden. Prize has served her time in this spirit, always looking to the example and comfort of the faith in her work. So, thank you, Prize, from me and from the church family. We know you will not be far away but hope that you will have something of a rest in the next year.

I need to thank you all for your cheerfulness and openness to new ideas and challenges. A special thanks to all those people who help on a regular basis, putting the church firmly in their diaries and showing, in faithfulness, their love of God.

God bless you all as we enter the post sesquicentennial year!

St James Church New Bradwell 2010

It has been a special year in the life of St James as it celebrated its 150 years anniversary the Church having been dedicated and consecrated for burial on December 6th 1860.

The first major event of the year was the open weekend and Flower Festival on Saturday 22nd May and Sunday the 23rd The date chosen as nearest to the anniversary of the laying of the foundation stone on May 24th, 1858. Local organisations and individuals provided floral arrangements that decorated all areas of the church, making a memorable display. All the floral arrangements can be viewed on the St James website.

The church was open all day with different events taking place alongside the flower arrangements and morning worship. These included entertainment by local musicians, and a quiz for children based on church artefacts and architecture. Lunches and cream teas were also available.

The main event of the year was the special Service of Celebration held on Sunday December st The Preacher and Celebrant was The Right Reverend John Pritchard, the Bishop of Oxford. The service was well attended and included the Mayoress, Debbie Brock, with her accompanying cadet for the day Tim Bell, and Mary Cotes the Ecumenical Moderator.

The special service booklet for the occasion had an embroidered panel on the front cover, each one of the 124 being individually produced over many weeks by Jennifer Cooper and Nicky Fleming.

To begin the celebrations a Barn Dance was arranged for the Saturday evening. This was well attended and greatly enjoyed by all ages, the music being supplied by "Sleeping Moggy".

Dave Folwell and Jennifer Cooper worked together to produce a booklet outlining a History of St James Church. Many thanks go to the New Bradwell Heritage Group who published it, supported by a generous grant from Milton Keynes Heritage Association. The booklets were given to the local school and handed out free during the weekend of the Flower Festival. The back cover of the booklet includes a picture of the congregation outside the church.

Dave also arranged for a display cabinet in the South aisle to display New Bradwell, Stantonbury and Church memorabilia.

These included a Cup and Saucer, each with a monochrome picture of the in 1902, crested china, photographs and other related items.

This was a memorable year in the life of St James New Bradwell.

Stantonbury Ecumenical Council

Looking back over the SEC minutes for 2010 we seemed to deal with many meaty subjects which I can only highlight to you otherwise I would have to write a book. If you would like any further information on any of the subjects 1 can make the minutes of those meetings available to you.

The LEP Review mentioned in last years report was completed and is now being digested and worked on by the SEC committee. Again copies of this can be made available if required.

We lost Dave Bell from the team when he was licensed and went off to Watling Valley and we gained the Rev. Liz Baker who was also newly licensed and came from Wading Valley so the status quo remained the same.

The Parish agreed to support Venture FX which is a Methodist sponsored scheme to work with predominately non church going 18-30yr olds. We also agreed to become part of Citizen MK after Moussa Baraka came to the Parish to explain what the role of this partnership is.

It was also agreed to fund a newsletter and we have seen the result of this recently please pick up a copy of Network from church if you have not read this yet.

Parish Wardens were elected for the first time, this role is needed for legal purposes within the SEC. This does not remove the work of our Church Wardens who we now call Officers but it does remove some of the legal responsibility. Bob Cross from the Cross and Stable Church and John Figg from Willen Church agreed to stand for these posts.

The SEC is trying hard to sort out the Sharing agreement for St James and the absolute farce that is the New Bradwell Community Centre Lease. Both of these subjects have serious implications for us at St James and we must hope and pray that they can be sorted out this year.

The SEC is made up of all of our clergy and lay Ministers plus two representatives from each Church. They make all the important decisions for the Parish and these decisions affect us so please do take an interest in what they are doing for us and support them whenever you can.

The Third Friday Group

You may come across the title T3F. T3F stands for The Third Friday group. This is a meeting for young people who have begun secondary school and we meet guess when, the third Friday of the month. We are a small group of around 5, mainly,

but not only from St James' church. The group is run by Mindy and Chris and has replaced the Film Group. We follow the Youth Emmaus scheme but when that leads us off to watch a film we do so. This term we have looked at generosity, the gap between rich and poor and watched the film Pass it Forward. We have great fun, heated discussions and amazing ideas! It has been great to have help from some members at our Open Door services.

Financial Report 2010

We started 2010 with a fairly healthy brought forward balance of £5,322 in our unrestricted accounts ie: our current account and the petty cash and £10,560 in our restricted accounts. The restricted funds are Ring fenced for particular needs and must not be used for the general running of the church there is a list of these accounts on the last page of the attached accounts.

At the AGM it was agreed to carry on with the Dodge the Deficit campaign in which we were trying to raise an extra £3,000 by the congregation each donating at least £30 which they could raise in any way they liked as long as it was legal! We actually raised £2,746 which was brilliant and it enabled us to pay £30,000 towards our Parish Share. We had committed to pay £28,000 towards the Parish Share which is actually a lot lower than we should be paying realistically, so the extra £2,000 went towards helping the Parish meet its costs. This year we are committed to paying £30,000 and it would be great if we could raise more.

In 2010 we had 79 members on our Electoral Roll most of whom have pledged income to the Church. This pledged money on which I have to rely comes to just short of £23,000 plus another £4,000 to £5,000 recovered from gift aid, so you can see that our pledged income does not even cover the cost of the Parish Share let alone all the other costs of running the church. If we all increased our giving by £1 per week we would raise an extra £4,108 per year. I realise that some of us cannot afford even that but I do ask you to give some thought to what you could afford and to increase your giving on a weekly basis as it is the regular giving that St James has to rely on.

The Methodist Chapel was finally sold and St James stands to gain approx £125,000 from this sale. This money must be used to add a new facility to the hui1din~' of St James and the hope would he to add a small meeting room plus toilets. However we cannot have this money until we have a legal Sharing agreement with the Methodist Circuit. Chris has spent the last seven years making herself ill trying to get this ratified and hopes that we have it in place before she leaves us. The money also has a five year time limit on it so the clock is ticking on this one!

We will still need to fund raise as half of this money goes into our Fabric fund which is now not as healthy as the accounts suggest as we have just paid out over £3,000 pounds to have the chimney made usable. We therefore need to make sure that we will have funds to continue to keep the building in a safe condition. The recent Quinquennial has highlighted other works that we need to pay attention to and I refer you to the Wardens report for these, we will of course apply for grants where possible.

It was decided that the Soup Run accounts should be taken under the SEC umbrella as ft is a parish wide activity. I was happy to hand these over as it makes the St James accounts easier to manage. I think that the accounts are fairly straightforward but please don't hesitate to speak to me if you have any questions. We go into 2011 with less money than in 2010 so we need to dig deep in order to continue to cover our costs.

I would like to thank Danny for yet again carrying on his role as Gift Aid and Envelope Scheme coordinator it's such a relief not to have to take on those jobs myself. I also thank John Porter for continuing as the 100 Club coordinator, and all the usual members of the congregation who always give up their time to make sure that our regular fundraising events take place such as stalls at the May Day, Summer Carnival, and Christmas Bazaar events. The funds raised from these events all add up and we rely on them.

Minister's Report

2010 has been a busy year full of variety. The main event in the early part of the year was the planning, preparing and staging of a Community Arts Festival, on behalf of the SEP. The event took place a week before Easter beginning on Saturday March 27 when we set up an art exhibition which displayed art from our local schools, art groups and from individuals. We arranged concerts, drama presentations and poetry reading on Saturday, Monday, Tuesday and Wednesday and had a wide cross section of the community involved. The schools made visits to the exhibition and were particularly taken by the sculptures lent to us by David Moore. This was a popular and enjoyable event and we are grateful to the variety of people who took part.

Following on from the Arts Festival we ran an Essence course on Thursday evenings from April 29 to June 10 with five participants. The material was much appreciated and led to some interesting discussions and art creations, as we explored our Christian faith together.

Brian and I attended the Baptist Assembly from April 30 to May 3 in Plymouth the theme of which was 'One world, one mission'.

The ongoing mission of the church was in our thoughts as the Church Council met to look at the role of the leadership on June 5 and then when the congregation met for art @home morning on June 12 and discussed the role of small groups.

The previous @home had led us to us forming a Social Committee so we could arrange social activities on a regular basis to which we could invite friends and family. We held a Burns Night on January 25 which was well attended and much enjoyed as we piped in the haggis and read poems after the meal. We had a car treasure hunt on July17, a ramble around Newport Pagnell on July 28, a barbecue at the manse on August 29 (when we tried very hard to keep Steve, Sylvia and Roger dry when the heavens opened!), a day away at Penny's uncle's on September 11 and a Harvest Supper on October 2. These were all enjoyable events which helped us to get to know one another better and to invite friends and family.

The other contact we have made this year is with a Muslim group. We met in June and October to dialogue together with the aim of understanding each other better. This has been quite informative and is an ongoing conversation.

I have taken two weddings in the building this year, one for an African couple in August and one for Jo and Dan in October. Jo attends our 9 am service.

On the second Sunday of each month, throughout the year, we have included members of the congregation or the house-groups either to preach or participate in a café style service. This has helped to add to the variety of our services and made use of the many gifts we have amongst us.

We can be very grateful to God for all that he has taught us in the past year through our life together, and for all the hard work done in maintaining the building, working with children and senior citizens and participating in the life of our neighbourhood.

We look forward to all that ahead as plans for the site development are beginning again and as we seek to strengthen our own sense of identity and mission in 2011.

Secretary's report

During 2010 Church Council has met regularly at approximately two monthly intervals. We had an extra meeting, mentioned in Chris's report, at Bradwell Chapel on a Saturday morning in June, with the twin aims of getting to know each other better and looking at the role of leadership within the church.

Three members of Council come to the end of their terms at the AGM. These are Maggie Prisk, Claire Vogeli and Cis Jones. Maggie and Cis have the option to continue attending Council in their roles as lay ministers of the church. We believe Claire may be rather busy with a new arrival I We are grateful to all three for their time on Council and to Claire for her competent chairing.

Over the past five years we have consistently failed to recruit a full Church Council. Nine members is probably a bit unrealistic given the size of our congregation but we now have only two Council members left (excluding the Treasurer and Secretary). Please do consider prayerfully whether this might be something God is calling you to do.

Our membership stands at forty three, one less than last year. Kim and Jenny Matthews have come off the membership list. We are sad to lose them but we are happy that they have found a church fellowship near their new home in Kenilworth. The addition to our membership is Gladys Martin who was baptised here and plays an active role in our church life. We welcome her to our 'church family'.

Treasurer's Report 2010

2010 proved to be financially better than anticipated. We had a deficit in the budget for the year of £2,549 but ended the year with one of £770.10. This includes having made provision for bad debts on some of our outstanding rent payments (some of which we may still receive) and having to pay some legal costs over the employment status of our former cleaner.

The situation was made financially better because there were several weeks in the summer when we were not paying a cleaner and we received no gas bills from September to January as we changed suppliers and the new supplier had not caught up with the billing. The Gift Aid receipts are larger because we claimed 15 months in 2010. We were able to meet our Mission Giving targets for the year in full.

The rental income appears less this year but there are less 'fees receivable' which may have given an over optimistic view in the 2009 accounts.

This coming year will prove quite a challenge as we have a number of items of maintenance which may well exceed the £5,000 provision in the budget. We may be able to get some funding and grants to help make some essential safety repairs to the roof. Utility costs have increased despite changing Gas supplier so we have fitted some new heating controls to try to limit this.

I am grateful as ever to those who donate so much to the day to day running of the church and urge you to continue as it is your regular giving that forms the bulk of the church's income.

Stantonbury Ecumenical Council

Stantonbury Ecumenical Council meets five times a year with the addition of occasional Saturday mornings where there is a need to focus on a specific issue. Its membership consists of two lay members from each of the churches plus the clergy team. There is also a lay treasurer. It has a Standing Committee that meets between main meetings to set the agenda.

The role of SEC is to consider matters of shared interest to all the churches. In addition to the care of their churches all minister except one have an additional responsibility. Andy Jowitt is the Evangelism Enabler, Chris Collinge is responsible for Children and Families, Chris Howden has a responsibility for the Creative Arts and Peter Ballantine has a role in Training. Paul Smith has no second role as he has two churches to care for. He is also the Team Rector. Mindy Bell has a part time role representing the Methodist Church, working most closely with St. James, New Bradwell.

During 2010 SEC had an Ecumenical Review conducted by a group of five people, two of them lay members of this church. A meeting was held to discuss the report. One outcome is that the Ecumenical Parish has become the Ecumenical Partnership in order to reflect the diversity of the denominations. (Parish is an Anglican term). We are also in the process of obtaining Charitable Status for the Parish and we recently joined Citizens MK.

SEC holds its meetings in all the churches in turn so there is an opportunity both to visit other churches and to meet people. Claire Vogeli and I currently represent Christ Church on the SEC but there is an opportunity at the AGM for new volunteers. Please talk to us if you would like to know more.

Worship and Music Groups

Music is an important element of our worship and we are grateful to those who spend time, planning, practicing and contributing their talents. Our musicians have not only provided a wide range of music for our services but also for services elsewhere in the parish and for community events such as the Christmas Concert. They meet to practice on Sunday evenings.

Junior Church

Pastoral Care Group

This group meets from time to time to pray for and discuss how we can support those in pastoral need. This includes visiting people who are linked to the church through the various groups that meet here and family and friends as well as members of Christ Church who find it difficult to attend church. This group

is led by our minister, Chris Howden. Chris also visits those of our fellowship who are unable to get to church and takes them communion. She also leads worship in Hanover Court and Heron Lodge, our two sheltered housing schemes.

Pastoral matters of general concern to the church are sometimes referred in confidence to Council Meetings.

If you are in need of help, or know someone who is, then please approach the minister or any member of Council and they will pass on your concern to either Chris or the group.

We also have a trained Pastoral Counsellor, Chris Solly, who can help as required.

House groups

House groups are an important part of our life at Christ Church. Everyone is welcome to join a group on a regular or occasional basis. We aim to explore our faith through study in a relaxed and informal way and to support each other in our Christian journeys through life.

The times and venues of the weekly groups can be found on the front cover of our monthly notices. Lunch and Learn, an inter church group, meets monthly in the coffee lounge on the fourth Wednesday of each month. An hour of study is followed by a soup and sandwich lunch. It is ideal for older people who may not wish to go out in the evenings. It meets weekly in Lent to do one of the York courses.

Once a month on the fourth Wednesday the church meets for an evening prayer meeting in one of our houses. A list is published of the venues. Please ask if you would like one. Prayer is vital to the life and growth of the church.

During the summer a few events of a mainly social nature replace the house groups and other social events take place throughout the year arranged by the Social Committee.

Kid's Club

Kids' Club had a slow start and its viability was at one time in question but over the year numbers have picked up and we now have ten children regularly attending and one older child who has stayed on as a 'Junior helper'. We enjoy a varied programme of arts and crafts, games, puzzles and cooking. Each week we have painting in some form and a construction activity and we deliberately keep the session relaxed and offer choices as we feel the children have enough structure in their day at school.

The holiday club, as Chris has commented, had lower numbers in common with other summer provision. Perhaps now we have the services of the Regeneration Team in our area we will have more knowledge of what people really want in the holidays for their children?

We are grateful for the many donations of paper, useful 'junk', jars, fabric, greetings cards and other items which we receive.

These help save money and also the planet! Finally if you have any adult T shirts you no longer need some of our existing ones are nearing the end of their useful life. We use them to cover up the children's school uniforms when they are doing messy activities.

Senior Citizens

It has been a year of ups and downs for the Senior Citizens' Club.

Age UK (formerly Age Concern and Help the Aged) has now taken over providing transport for Lunch Clubs and this includes our group. They have contracted the job out to Bill's Taxis and this, on the whole, has been better for us, though we are now paying for transport but the cost is only £1 per person per week.

Our numbers have diminished over the past year as three of our members died in the past eighteen months and two have stopped coming - mainly due to transport issues. We currently have ten members on our books but usually only eight or nine in any given week.

The ones who continue to come do really enjoy the club, however, and for some it is the only chance they have of getting out and meeting friends. They are like a family to one another.

We recently had a trip to Frost's Garden Centre. Chris Howden kindly cooked a Christmas meal again for us and we had Wood End First School to sing on that day and each of the Senior Citizens received a hamper from the Campus.

Nancy Dua continues her staunch work of washing up and giving out drinks each week and we are very grateful to her.

The club continues to function with Ruth Walker-Singh, Nancy Warner and myself running it week by week but our future is uncertain as all of us have increasing family commitments which make it difficult for us always to be around. Usually we manage with two out of the three of us and help from Chris but as time goes on, and sadly we are all getting older, this becomes more of a problem. We will continue to keep going as long as we are able but we will be grateful for your prayers and any offers of help for the future.

b. Minutes of the annual general meeting held Sunday 15th March 2010

Present: Paul Smith (Chair), Helen Eaton (Secretary) and other members of the Church.

1 Minutes

1.1 The minutes of the meeting held 15th March 2009 were approved as a correct record.

2 Matters Arising

2.1 There were no matters arising.

3 Annual Reports

- 3.1 The following written reports were received:
- (i) Willen and Downs Barn Minister's report 2009-10 from Paul Smith;
- (ii) Licensed Lay Minster's report from Margaret Moakes;
- (iii) Pastoral Care Scheme report from Margaret Moakes;
- (iv) Annual Report from the Fund Raising Group from Hilda Kirkwood.
- 3.2 Paul Smith reported orally that the fundraising group which had been originally convened to raise funds for the roof repairs would continue to meet and would direct their efforts to general fundraising for the Church. This group was important to the social life of the Church as well as being valued for their fundraising efforts. Church members who might wish to suggest work which should be done to the fabric of the Church should contact Bill Green, Michael Kemp or John Figg.

4 Repairs to Church roof and north vestry project

- 4.1 A written report on the roof and redecoration works was received from John Figg.
- 4.2 Paul Smith reported orally that the architect who had carried out the last survey of the Church had recommended that the exterior door be renovated and gilded. This renovation work had been contracted and, when done, this would complete the 'Under One Roof' scheme.

5 Financial statement for 2009

- 5.1 The financial statement had not been completed in time for the meeting and it was agreed that this should be made available to members in hard copy and by email in the weeks following the AGM.
- 5.2 Paul Smith reported orally that, whilst the Church was still solvent, there had been a decline in the amount by which the budget was in credit year on year. This situation would be considered in more detail at the next Church Council meeting.

7 Elections

This was necessitated by a new legal requirement for churches to register with the Charity Commission, and a form of constitution based on a model devised for Local Ecumenical Partnerships had been adopted which required the election of two Parish Wardens. The new constitution would take effect from 22nd April 2010 and the Parish Wardens would be elected at the forthcoming Annual Parish Meeting.

8 Any other business

- 8.1 It was announced that Pat Clark was continuing to offer to provide meals under the banner 'dinners for dignity' for small groups of people. Pat would be happy to cater for groups of up to seven individuals, providing at least one person from the group was known to her. Funds raised from the dinners would be given to the charity 'Wherever the need'.
- 8.2 It was reported that Gift Aid envelopes would be distributed in time for Gift Day. 2010 Gift Aid at Willen was being coordinated by Sean Miles.

- 8.3 A motion was put before the meeting that the swine flu precautions, including the use of individual disposable cups during the Communion, should be discontinued and that normal practice should be resumed. A number of views both in favour of retaining the use of disposable cups and for returning to normal practice were noted.
- 8.4 It was agreed that normal practice for serving Communion using the chalice should resume, the exception being during Baptist Communion services when disposable cups would be used.
- 8.5 It was reported that gluten free wafers were available for those who needed them.

9.1 It was reported that the date which had been originally proposed for the Willen 2011 AGM clashed with the agreed date of the Downs Barn AGM. It was therefore agreed that the next meeting should be held on 27th March 2011.

d. Annual Reports for 2010

d.i. The Minister's Report

Over the last year I have continued to try and develop the joint role of being Minister with pastoral charge of both churches within the Stantonbury Team, combined with being Team Rector (which, in effect, is a minor role). As Minister of the two congregations my emphases in the past year continued very much as detailed in previous reports. The main points to note over the last year include:

AT CROSS AND STABLE

- Continued decline in the number of people attending Cross & Stable church for a variety of reasons including removal from the area, frailty, and some significant deaths
- Increasing pressure on fewer individuals helping to run the building
- Recent initiatives have included:
 - > Raising our profile: we are pleased that the building now has a visible name on the exterior and are grateful to the Management Committee for doing this; Christmas advertising was well received, we are grateful to those who took initiative and made arrangements for a striking handbill and poster design.
 - > Running an experiment with the arrangement of our seating and concluding with a modified form of our habitual Sunday morning shaping. This was a result of our Thinking Morning and resolving to run an experiment.
 - > Planning four quarterly evening services in Cross & Stable for the whole parish
- The monthly services for the deaf have continued to be

- well attended and the signed carol service was successful again. Informal carols were well-attended and are becoming a fixture.
- Agreeing a significant decrease in our contribution to the parish share

AT ST MARY MAGDALENE

- Continuing to care for the building and its fittings in various ways: most recently, improving the wood panelling (an ongoing task) and upgrading the PA system.
- It is hoped to bring mains water to the exterior of the building during the coming year.
- The licensing of Rev Liz Baker, a former member of the congregation and now Leader of the Well at Willen, as an Associate Priest in the Stantonbury Partnership.
 Margaret Moakes continuing ministry as Licensed Lay Minister (leading worship, leading small groups and in pastoral care and spirituality for others)
- Working with the Well in mutually enriching initiatives, including continuing a monthly healing service in church
- Enjoying some social and fund-raising occasions for general fund raising
- Continuing occasional interfaith meetings: Jewish and Muslim so far.
- Celebrating a significant increase in the number of weddings in 2010 and providing marriage preparation using resources and personnel from our own congregation
- Quorum as part of whole Partnership pattern of evening services throughout the year.
- Visit to Westminster Abbey involving members from around the Partnership

GENERALLY

- Continuing a Christian group at the new Lovat Fields Retirement Village ("The Tree of Life Group"); wellattended Christmas carol service and Remembrance Day services.
- Continuing with local schools, recently adding Brooksward to the schools I visit
- Occasional chaplaincy cover at Willen Hospice;
- Welcoming some visiting preachers at both churches during the course of the year and having members of the Stantonbury Ministers Team visit to take services from time to time

CHALLENGES, OPPORTUNITIES AND ISSUES WHICH FACE US ARE:

- Continuing to define a clearer relationship between the Well and St Mary Magdalene Church and promoting consciousness of that
- Meeting our responsibilities of care for the upkeep of both buildings through volunteers
- Pastoral care at both churches
- Supporting the parish share and other charitable causes through our giving.

d.ii. Report from the licensed lay minister

My main areas of concern at Willen are (1) the First Sunday Service at 9.30 am (Morning Worship) and (2) oversight of the Pastoral Care Co-ordinators Group. In addition (3), I am on the Organising Group for Weeks of Accompanied Prayer in the wider parish. Among other things, this group offers training for accompaniers and spiritual directors.

(1) Monthly Morning Worship draws in a steady stream of worshippers, although the people concerned can vary from month to month. As well as working with Paul, I also like to work with other members of the clergy team in the Stantonbury Parish. It all makes for a variety of approaches. I also feel it is good to involve various creative people in our own congregation, so over the past year there has been input from the flower arrangers and from the musicians.

I'm hoping some of the families can be persuaded to lend support on Mothering Sunday at the beginning of April. Watch this space!

(2) The Pastoral Care Co-ordinators meet regularly, for which I am grateful. Each of them has oversight of a geographical area, seven in all. They keep an eye on regular attendees within their locality, as well as updating their lists to include newcomers. There is a special approach around Christmas to ensure members of their groups have information of services over the festival period.

Two new initiatives are on the cards. One is issuing invitations to marriage couples from the previous 12 months to attend for special prayers at an anniversary service. I am very grateful to Lynda Phillips for keeping this one within her sights. We are hoping to extend this idea to an initiative for baptism families. There will be a similar aim of inviting families to an anniversary-reminder/celebration service.

(3) We were delighted to be able to offer a Week of Accompanied Prayer at the Well again in 2010, which was open to 'seekers' from the whole of the Stantonbury Parish, as well as members of the Dayspring Groups that meet at the Priory. Two people from Willen joined in the group of around 15 'pilgrims' and 6 'accompaniers', who gathered daily for a 7-day event. It was very fulfilling for all concerned.

In the coming year, we are moving our outreach to Milton Keynes Prison, and your prayers would be much appreciated. However, we hope to become local again in Lent 2012.

d.iii. Building Report for 2010 - 2011

Now that the new roof is in place, the north vestry underpinned, the interior of the church repainted and the entrance door refurbished the principal maintenance items have been taken care of.

One long-standing desire has been to have a water supply connected to the church and a feasibility scheme has been developed to bring water from the mains in Milton Road via the east gate of the church to terminate with a tap outside the wall of the north vestry. Once the concept has been approved quotations will be sought. There is a designated 'tap fund' already set aside, which was begun in memory of Bet Morgan, late Churchwarden and dedicated helper for the church.

By the generosity of the Cross & Stable Charities money has been made available to replace the deteriorated notice board at the west end of the limetree avenue to the church and for the installation of a new notice board justinside the east wall of the churchyard near the gates (and pillar box). At present formal permission from Milton Keynes Council and granting of a Faculty by Oxford Diocese are in process.

There has been a difference of opinion about the function of the floodlights in the churchyard — whether they were intended to illuminate the tower/outside of the church so that it can be seen at night across the lake from Portway or whether the lamps should be aimed at the pathways around the building to enable people to see their way to the church door. Now both objectives have been satisfied by installing an additional two lamps in such a way that two floodlights on the post are aimed at the tower and two floodlights are directed towards the paths. The lamps are not required very often and the electrical demand of 2 kW is only for a few hours per year.

The speech reinforcement system and hearing loop installation has been updated to a dual-frequency arrangement through the good offices of Richard Robinson of Sound Facilities Ltd. It is hoped that the upgraded system will improve audibility and reliability of the equipment and the cabling has now been tidied up and simplified.

The lightning conductor on the tower was inspected and tested by specialists, Messrs Stones Technical Services, and found to be electrically satisfactory, but to be in need of refixing to the tower brickwork. This work has now been commissioned.

During the cold weather this winter it was uncomfortably cool in church; particularly for early morning services and it transpired that the north side apse storage heater was not functioning. Paul Eveling, Domestic Electrical Services, has now remedied the situation and it is hoped that congregations will be more comfortable in future.

Most recently refurbishment of the internal woodwork of the church has commenced with volunteer helpers cleaning the apse panelling using fine steel wool and detergent to remove accumulated grime (smoke from candle and oil-lamp illumination and coal-fired heating) and then treating the cleaned wood with linseed oil/tung oil emulsion. This has greatly improved the appearance of the panelling at the east end of the church and enthused congregation members to tackle the Nave and Choir areas.

In the near future it is hoped to adjust the pew-ends and pew doors to enable the doors to be more easily opened and closed and to prevent scraping on the floor.

d.iv. Quorum Choir Report

Quorum continues to sing at a range of services at St Mary Magdalene. Over the past few years a pattern of services at which Quorum sings at has become established to include services on Palm Sunday, 1st Sunday of Advent and the annual Carol Service.

During the past year, Quorum provided music for Ascension, Pentecost and Trinity (May 2010), St Michaels and All Angels (end of September 2010), Willen's Patronal Festival in July 2010, Service for the licensing of Liz Baker in late September 2010, Carol Service Dec 2010 and Candlemas January 2011. For each of these services Quorum has provided music from its core repertoire of renaissance sacred music appropriate for the service. For the Carol Service Quorum sings Christmas music by contemporary composers in English. For the service in 2010 Quorum had prepared a set of music including newly published carols, which had been highly commended in the music press, but regrettably a heavy snow storm the previous day meant that many of the singers were unable to travel to the service.

For the words and music services, Quorum works closely with Rev Paul Smith on the shape of the service, trying out new approaches to convey the spiritual message of the service. For Palm Sunday, Quorum will be singing a selection of pieces from the Victoria Tenebrae Responsories, 2011 being the 400th anniversary of Victoria's death. For this service Quorum will be singing pieces for each of the three days (Holy Thursday, Good Friday and Holy Saturday) as a group to convey the words which Victoria set in a more coherent way.

Quorum continues to have an annual Cathedral visit. In 2010 Quorum sang at Hereford Cathedral in February and, at short notice, sang an Evensong at Worcester Cathedral in June. In 2011 two Cathedral visits are planned: Ely Cathedral on 9 & 10 April and Chichester on 29 & 30 October.

d.v. Vergers Report.

Last year we had an appeal for money for flowers for Easter we had a wonderful response from both the congregation and friends of the Church and raised £150 this gave us enough money to decorate the Church for Easter with money left over that we used for both Pentecost and Harvest the last £1.50 being put into that weeks collection. We will once again this year be asking the congregation to please help with Easter Flowers

I placed a Rota for Church cleaning in the porch again in January and Paul asked those who could help to sign up for it, unfortunately only one person has come forward so far, Julie McClay and I do it between us alternate months but it would be a help if we had more people on the list, after all we all like a clean and tidy place to sit.

A big thank you to all of those people in our congregation who help with decorating the Church during the year, helping with the Summer fete and working in the gardens also a big thank you to everyone who helped with the wood renovation.

We not only say thank you to members of our congregation at St Mary Magdalene but also to the many supporters who help at different events who do not attend our Church but whose help is greatly appreciated and much valued.

d.vi. Report of social and fundraising group:

The members of the group during 2010 were: Mary Hartwell, Fr. Frank Green, Norma Bowden Clark, Rosemary LeCount and Hilda Kirkwood.

The following Events were held:

- · Quiz evening with supper,
- · Summer lunch in Pat's garden

- · Afternoon tea at Lovat fields
- · Trip to the stained-glass museum at Ely
- · · Harvest supper
- · Concert in church given by Polymnia

The members of the group also assisted at the licensing of Rev Liz Baker in September and the stocking and manning up a store at Newport Pagnell Christmas light celebration.

Members of the group make preserve to sell throughout the year, sell our own Willen church details were ever there is demand and circulate the Traidcraft catalogue from which we recover commission. Al these activities raised £547.

In addition the Newport Pagnell line store raised £223.

There is still a separate account held entitled 'under one roof', which enables us to purchase re-saleable items such as tea towels. It currently has about £420 in it.

At the November 2010 meeting of the church Council I presented a report seeking views on the future of this group, its value to the life and work of our church and what events members will support in the future these matters are still being debated.

One of the missing skills at the moment is someone to design publicity and help with its distribution. If you are able to help with either or both of these functions please don't hesitate to contact me!

d.vii. Associate Minister's report

Since my Licensing on 29th September, I was circulating in the Parish for the first 3 months and visiting the churches.

Highlights have been: The Carols by Candlelight - when unexpected numbers came and thanks to the amazing efforts of Quorum and the congregation it was truly a fantastic service.

The same is true of the Christingle Service when again through the frost and snow large numbers turned out to sing and celebrate the season. The service raised over £60 for the Children's Society, which is very encouraging.

It very nice to be back in the parish once again.
